### 3. Affiliate Membership with Consumers International for 2024

George Cheriyan, Honorary Working President of CPA initiated the process for the membership with CI by sending a mail to Tamara Meza, Global Networker Lead, Consumers International on May 23, 2023. The duly filled application for CI application was submitted with all required documents, such as annual reports for 3 years, audited statement of accounts, list of office bearers, copy of registration certificate etc. on June 24, 2023. Unfortunately, the application was regretted by the membership team, that was communicated through a mail on July 20, 2023 by Tamara Meza. George continued the follow up with CI for the membership. During the CI Global Summit held in Nairobi, Kenya, George had a one to one meeting with Helena Leurent. Director General of CI and discussed the CPA membership matter. In continuation George further followed up the matter with CI team. As a result, finally the Affiliate membership was granted to CPA for the year 2024, that was communicated through a mail dated April 2, 2024 by Ms. Charlotte Broyd, Head of Communications and Membership, Consumers International.

In continuation a membership fee of USD 45 for the year 2024 (9 months) was paid by CPA.

### 4. Programmes/Activities

During the report year several programmes were organized by CESDI.

#### 4.1. Observation of International Days

CPA observed the Environment Day (June 5), World Food Safety Day (June 7) United Nations Day (24<sup>th</sup> October), National Consumer Day (December 24) World Consumer Rights Day (15 March) during the year with different activities in different locations.

#### 4.2 Consumer Coordination Council (CCC)

Consumer Coordination Council (CCC) is the apex consumer organization, that was established in March 1993 as a Society registered under the Societies Registration Act of 1860. Consumers Protection Association (CPA) and its President Adv. Amrit Lal Saha are founding members of CCC and Adv. Saha is the past Chairman of CCC.

Visakha Consumer Council (VCC), a CCC member, established in 1978 celebrated its 50<sup>th</sup> Anniversary on August 31, 2023. Adv. Saha attended the jubilee celebration held in Visakhapatnam. He also attended the GB meeting of CCC held in Visakhapatnam. Adv. Saha also attended the CCC GB meeting and observation of World Consumer Rights Day (WCRD) held in New Delhi on March 15, 2024.

#### 4.3 In-house Internship

Four lawyers, practicing in different courts in Agartala, visited the office of CPA in December 2023 and interacted with Adv. Amrit Lal Saha, to get new insights on dealing with various consumer issues.

#### 4.4 Launch of Project on Electricity Governance in India

Consumer Protection Association (CPA) in partnership with Citizen consumer and civic Action Group (CAG), Chennai launched a new project "Accelerating Clean Energy Transition by Improving Stakeholder Participation for Electricity Governance in India", along with one-day seminar discussing the electricity issues in Tripura. The launch event was held on March 9, 2024 at Agartala Press Club, Tripura. The project is for a period of 9 months from March to November, 2024.

Mr. D. Radhakrishnan, Chairman, Tripura Electricity Regulatory Commission (TERC) and Ms. Dalia Shah, Member, Tripura State Consumer Dispute Redressal Commission (SCDRC) were the guests. 35 participants from

voluntary organizations, teacher associations, self-help Groups, and domestic consumers participated in the seminar.

Mr. Amrit Lal Saha, chaired the Launch Meeting and spoke about the interventions of CPA in Tripura, working in various sectors for the last almost 37 years, since 1987. Mr. George Cheriyan, Working President, Consumer Protection Association (CPA), extended a warm welcome to all the speakers and participants and made the introductory remarks. G.N. Bharath Ram, researcher, CAG, presented the significance of launching a project in Tripura. The project aims to empower consumers and enable their greater participation in the electricity sector, while also enhancing their understanding of electricity governance, he said. A message from Mr. Abhishek Singh, IAS, Secretary of Department of Power, Govt. of Tripura was read in the meeting.

Mr. D. Radhakrishnan, Chairman, Tripura Electricity Regulatory Commission (TERC), highlighted the critical role that electricity plays in our daily lives. He appreciated the program's significant goal of accelerating the transition towards clean energy and promoting consumer participation in electricity governance. Ms. Dalia Shah, Member, State Consumer Dispute Redressal Commission (SCDRC), talked about the commission's core objective of helping consumers resolve their issues without any hindrance

### 5. Participation in National Events/Meetings

# 5.1 'Multi-stakeholder Forum on Sustainable Production and Consumption" held at Chennai on January 23-24, 2024

'Multi-stakeholder Forum on Sustainable Production and Consumption" was organized by Citizen consumer & civic Action Group (CAG), Chennai on January 23-24, 2024 in Chennai, seeking to provide a platform to bring together relevant stakeholders including government officials, businesses, civil society, journalists, and academics. The need for multi stakeholder participation in addressing complex subjects such as sustainability and the climate crisis was explained by Dr. Sultan Ismail, Member, Tamil Nadu State Planning Commission during his inaugural address. He emphasized that climate systems, for example, were so complex that they cannot be contained or mitigated by just one country or one sector of government working independently. It needs people and policies from different walks of life, working hand in hand, globally. This was reiterated by Helena Leurent, Director General of Consumers International, who gave a video address at the event. She explained that even well-meaning consumers need the right tools in the form of a sustainable ecosystem, if their intentions to live sustainably are to translate into real action.

The two-day forum looks at sustainability through the lens of business models and strategies impacting sustainability, analysing current production and consumption patterns, with recommendations for an ecosystem for responsible and sustainable businesses. George Cheriyan, Honorary Working President, represented CPA in the forum and made a presentation on 'Citizens perception of sustainable businesses' on January 24, 2024.
